



Shirley Meadows located at 27 Hospital Road, Shirley. Occupancy is anticipated to begin Summer of 2020.

Shirley Meadows includes 58-units of supportive and affordable housing designed to address the immediate needs of seniors, aged 62 or older, with incomes ranging from extremely low to moderate.

Fifty-five (55) one-bedroom units and three (3) two-bedroom units are available.

Each of the apartments has a full bathroom and kitchen. There are both handicap-accessible and adaptable units at Shirley Meadows. This design allows residents to remain safely in their homes in the event that their physical needs change.

The property also includes the availability of supportive services that provide information, advocacy and referrals to area agencies that deal with the individual needs of each resident.
