We continue to develop new affordable rental units in partnership with many developers to make sure that we are able to address the housing needs for all populations. When a development wins in a competitive funding round we consider layering in Section 8 PBV. Locations for Section 8 PBV slated for Chelmsford and Westford. We believe that we will be project basing up to 32 vouchers at four locations in Chelmsford and Westford over the next five years.</p>
B.3	<p>Progress Report.</p> <p>Provide a description of the PHA's progress in meeting its Mission and Goals described in the PHA 5-Year Plan.</p> <p>The CHA continues to expand the number of housing opportunities locally. We working with private and non profit developers to maximize the number of rental units being developed. We continue to negotiate with private developments to make sure they are aware of our need for units to leased with our Section 8 Program. The outreach has been successful and we have seen over 100 new units built by third parties in Chelmsford. We are currently working with a developer that is planning about 400 units in Chelmsford.</p>

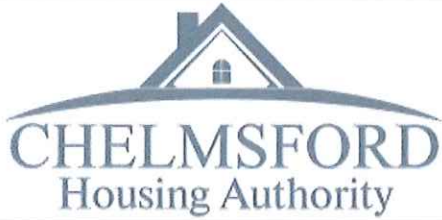
